### ITEM 4c)3. Employee Recognition – Administrator's Award

Deputy County Administrator, George E. Morrison, III advised that upon his arrival and after regular staff meetings, he found there to be no employee recognition in place merely an in room around the table acknowledgements of staff and their accomplishments. Recognizing staff for a job well done or for exceeding in their daily job duties for the good of the citizens of Sussex County is essential. Sussex County has an outstanding staff and they should be recognized when their performance warrants such recognition. Prior to the start of the current Fiscal Year (2009-2010), a committee was formed to set forth the requirements of the recipient of such an award, the title and design of the award, the nomination process, the evaluation procedure, and the frequency in which the award should be given.

The committee has decided the title of the award to be the "Administrator's Award." We have created a nomination form so that all employees can easily nominate someone they feel is deserving of the Administrator's Award. Each of these nominations will be reviewed by the committee and a successful recipient will be chosen. The award will be given quarterly to a fellow employee for an outstanding job performed and/or for going above and beyond their daily job duties to provide "Team Sussex and its citizens outstanding service. The award shall bear the signatures of the County Administrator and the Chairman of the Board of Supervisors. The award will be given to the successful candidate at the Board meeting at the end of each quarter.

The first recipient of the Administrator's Award is Mr. Montaque Gilliam. He was unanimously agreed upon by the committee. Mr. Gilliam went above and beyond his daily job duties in supervising the set up of the new Administration building. He did an outstanding job of coordinating the contractors, service providers and the affected staff. Mr. Gilliam is typically the first employee to work each morning and one of the last employees to leave each night. Often on Saturdays and Sundays, he is called to go somewhere for Sussex County and he gladly responds. Mr. Gilliam's outstanding service and dedication to Sussex County is why it is only fitting that he be the first recipient of the Administrator's Award.

The Award was presented to Mr. Gilliam by Mr. Morrison and Chairman Fly.

### ITEM 4c)4. CDBG Homeownership Planning Grant

Deputy County Administrator, Mr. George E. Morrison, III, advised the Board that included in their packet is a memorandum from Mr. Andre M. Greene, Director of Planning, providing information on staff's intention to submit a request for a planning grant to the Department of Housing and Community Development. The planning grant will be submitted to support the completion of a housing survey and preparation of a market study to evaluate the feasibility of a project to provide homeownership opportunities to eligible families.

### ITEM 4c)5. Broadband Planning Grant

Deputy County Administrator, George E. Morrison, III, advised the Board that staff intends to submit an application to the Department of Housing and Community Development (DHCD) requesting grant funding to support the completion of a needs assessment to evaluate the feasibility of providing broadband communication technology to Sussex County residents and businesses. The funds will also support an evaluation of the most effective means of implementing broadband technology (fiber optic based technology, wireless technology, public ownership and lease back program).

An amount not to exceed \$25,000 will be requested from DHCD by September 30, 2009 and will be used to achieve the following:

- 1) An inventory of existing infrastructure and analysis of infrastructure needs to implement broadband service countywide;
- 2) Itemization of broadband infrastructure needs with projected cost estimates;
- 3) Evaluation of varied funding strategies and implementation recommendation;
- 4) Identification of private vendors soliciting opportunities to provide like services in rural communities statewide;
- 5) Analysis of current communication and information technology capacity in relationship to need and demand;
- 6) Survey of potential users to assess income status, broadband needs and desired applications.

### ITEM 4c)8. State Budget Reduction

Mr. Jerry L. Whitaker, Director of Finance, reported that included in the Board packet is information regarding the Governor's FY 2010 Budget Reduction Plans. These reductions will impact the Compensation Board's funding for Constitutional Officers. They are as follows:

Sheriff's and Regional Jail – 4.7% appropriation reduction at \$19,539,996 Commonwealth's Attorneys – 5% appropriation reduction at \$2,522,576 Circuit Court Clerks – 15% appropriation reduction at \$4,231,307 Treasurers – 15% - appropriation reduction at \$1,590,015 Commissioner of the Revenue – 15% appropriation reduction at \$1,608,248.

This matter was referred to the Finance Commission for further discussion.

# ITEM 4g). Superintendent of Schools

Mr. David Papenfuse, Director of Finance for Sussex County Public Schools, addressed the Board regarding a budget amendment. He explained that during this biennium, the school district is eligible to receive considerable federal funding opportunities tied to the American Recovery and Reinvestment Act of 2009 (Stimulus Funds). Several sources of stimulus funding have been made available to Sussex school division as follows:

NCLB – ARRA – Title I, Part A Improving Basic Program \$307,900.35
 IDEA – ARRA – Part B Section 611 – Special Education \$332,837.00
 IDEA – ARRA – Part B Section 619 Special Education Preschool \$11,209.00

It is the desire of the Federal Government to fund projects that will provide significant and immediate impact. The funds have guidelines as to how they can be used for purchasing equipment, supplies and services. In addition, the funds cannot be used to supplant the regular operational or construction budget. As such, the School Administration is requesting that the Board of Supervisors amend the 2009-2010 Sussex County Schools Budget by the entire grant amount of \$651,946.35. The amended budget total will be \$19,975,010.35. These funds will allow for spending over a two year period and may require re-appropriation in the next budget year.

Supervisor Parker advised the Board that he thinks the Board should consider reviewing the concept of joining a regional jail. It may be a reasonable approach since the Sheriff's Department is the department in the County with the highest expenditures. Joining a regional jail may be a way for the County to reduce its expenditures.

Vice Chairman Tyler informed the Board that Brunswick County is hosting a Town Meeting tonight in light of the state's decision to close the Brunswick Correctional Facility. The Counties of Brunswick, Dinwiddie and Mecklenburg may be in regional jail discussions. This may be an opportunity for Sussex to get in on the ground floor. Sussex may need to consider aggressively pursuing this option.

Chairman Fly suggested that a committee be formed and a meeting with the Sheriff be scheduled to further discuss this issue.

Supervisors Harrell and Parker agreed to be on this committee.

Chairman Fly asked for Citizens comments.

Ms. Terry Massenburg, Henry District: "An issue has been brought to my attention. I was informed that allegedly, Mrs. Anne Joyner, Chairperson of the Sussex County Animal Advisory Committee referred to me by using a racial epithet. I was told that Mrs. Joyner made this comment to the Animal Pound staff."

The Board, by general consensus, decided to discuss this issue in Closed Session.

- ➤ Mr. Kevin Bracey, Courthouse District: "I am not thrilled with the way things are done here in Sussex County. At the last Board meeting, the Board approved GovDeals contract, but the cars are still sitting at the Animal Pound property. Board members don't want to listen to the citizens, they vote opposite of what they say. I think it's a joke. They build a new building, but hired a private contractor to do so, when you could have used inmates. The grounds look like crap and you are advertising to hire more people. You need to be putting a freeze on spending. Instead of putting the surplus vehicles on GovDeals, give local folk a chance to bid on them. Some people here don't have vehicles. It's atrocious. The dog pound situation has been going on for four or five years. The Board can do something to keep the State vet from writing us up. You Board members acted like idiots at the last meeting. I don't want you to represent me at all. All of you ought to be ashamed of yourselves. Why are we hiring a vet from Smithfield? It's a joke then you want to spend \$23 million to build two schools."
- ➤ Mr. Al Peschke, Wakefield District: "I thank you Mr. Birdsong for letting me use your copies of the budget. I thank the Sussex Surry Dispatch for putting a picture of the County's surplus vehicle on the front page, why are the vehicles still there? Let's not waste County money. When are we going to get copies of the County's budget placed at the County libraries?"
- ➤ Ms. Deborah Davis, Assistant to County Administrator advised that a copy of the Fiscal Year 2010 budgets have been personally delivered to the libraries in both Waverly and Wakefield.

- ➤ Mr. Fred Turck, Blackwater District: "We were told that we could not take pictures of the animals at the Pound and I want to know why."
- ➤ Ms. Ora Briggs, Stony Creek District: "In regard to the funding of the elementary school facility, what is the status of the appropriation?"
- > Chairman Fly: "The Board of Supervisors has to hold a public hearing for funding to build the schools."
- ➤ Ms. Ora Briggs: "But, how can the project move forward, if the Board of Supervisors' vote is illegal? How can County Administration move forward?"
- ➤ Chairman Fly: "The County Administrator takes direction from the Board of Supervisors. There are four members voting that believe that the Board's decision is correct; but the School Board may seek legal remedy."
- ➤ Ms. Ora Briggs: "Who pays for the legal decision?"
- ➤ Chairman Fly: "The County will."
- ➤ Ms. Ora Briggs: "Taxpayers will pay for this? The code states what the Board of Supervisors needs to do. You all need to use common sense, just admit if you have made a mistake."
- ➤ Chairman Fly: "We appreciate your comments, but you can ask me the same question ten times and the answer will be the same."
- ➤ Ms. Ora Briggs: "When the members of the Board of Supervisors intentionally violate the law, you have problems."
