WHEREAS, the Director of Planning has advised the Board of Supervisors that further review of the Kennel Amendment and all provisions of the Use Regulation sections of the Sussex County Code of Ordinances relating to commercial and noncommercial kennels is necessary by the County's Planning Commission, and

WHEREAS, the Board of Supervisors, until such review, recommendations and necessary public hearings and public comments are completed cannot deliberate and act upon any formal zoning amendment(s) to the Code of Sussex County, if the same be appropriate, for incorporation, by codification, to the County's Zoning Ordinances; and

## Item 5b6. Building and Grounds Committee Report

Supervisor Birdsong, Chairman of the Building and Grounds Committee, advised that the Committee has met with the Commonwealth's Attorney to discuss the proposed addition for office space. He advised that the architect (who was not present at the meeting), had forwarded floor plans to be reviewed. However, Mrs. Lyndia Person-Ramsey, the Commonwealth's Attorney, is not comfortable with the floor plan that has been provided by Dewberry. The Building and Grounds asked the Commonwealth's Attorney to contact the architect and request a re-design and then develop a plan that Mrs. Ramsey can be comfortable with and then the Building and Grounds Committee can schedule another meeting.

George E. Morrison, III, Interim County Administrator, advised that the office space currently occupied by the Commonwealth's Attorney has faulty wiring and creates a safety hazard. Mrs. Ramey has contacted Cook Electric and asked them to look at the wiring situation in her office. Mr. Wayne Cook provided an estimate to perform the electrical work that is needed. The cost estimate is \$2,500.00 to \$5,800.00 and was recommended by the Finance Committe to ask for the Board's approval.

## Item 5b10. Public Safety Coordinator Request – New Ambulance

Eddie T. Vick, Public Safety Coordinator, advised that the Waverly Rescue Squad has been awarded funding for a new ambulance to replace their oldest unit. This older unit has served the citizens well, but is no longer functional.

Waverly Rescue Squad has been awarded \$107,680.00 in grant funding toward the purchase of a new ambulance. The new ambulance will cost approximately \$153,253.00. This amount includes the ambulance, installation of the radio, new stretcher (cot) and stair chair. The ambulance will be purchased by Sussex County, utilizing the County's 10-year ambulance contract. Upon Waverly Rescue Squad receiving the grant funding from the State, they (the Squad) will provide reimbursement to the County in the amount of \$107,680.00.

**<u>REQUEST</u>**: Staff is requesting from the Board of Supervisors, funding in the amount of \$45,573.00 (the difference) for the purchase of a new ambulance for the Waverly Rescue Squad.

ON MOTION OF SUPERVISOR TYLER, seconded by SUPERVISOR CAPLE and carried: RESOLVED that the Sussex County Board of Supervisors hereby approves of the request to approve and appropriate the amount of \$45,573.00 for the purchase of an ambulance for the Waverly Rescue Squad.
