# Item 4a. Comprehensive Plan Amendment #2013-01, Meadowview Biological Research Station, applicant

The staff report was provided by Shilton A. Rick, Permit Technician.

The applicant, Meadowview Biological Research Station, is requesting an amendment to Sussex County's Comprehensive Plan Future Land Use Map for the Blackwater/Newville/Waverly/U. S. 460 Planning Area to change the designation of one (1) certain area of real property identified as tax parcel number 12-(2)-3A, located on the north side of Route 602 (Cabin Point Road) in the vicinity of Joseph and Dobie Swamps. The property in question is also located in the Blackwater Election District. The Comprehensive Plan amendment proposes to change the designation from future residential to future agri-cultural/forested/open space.

The applicant is requesting the amendment to the Comprehensive Plan in order to establish a conservation easement containing approximately fifty-one (51) acres on the subject property. A conservation easement is a legal land use tool which allows property owners in Virginia to voluntarily limit development of their property while keeping the land open to forestry, farming, outdoor recreation and other agricultural activities. A conservation easement is a voluntary agreement between a landowner and a qualified conservation organization or public entity to prevent the development of property while allowing the continued ownership and rural use of the property for activities such as farming or forestry. When a landowner enters their property into a conservation agreement, they surrender some or all of their rights to develop the property as well as the right to most industrial/commercial uses of the property such as mining. Conservation easements typically allow for sustainable farming and forestry practices.

Meadowview Biological Research Station is proposing to place a conservation easement on tax parcel number 12-(2)-3A in an effort to improve water quality on the fifty-one (51) acre parcel in question, which is located at the headwaters of the Nottoway River. Water quality will be improved by the cessation of grazing activities, implementation of an enhanced three hundred (300) foot wetland buffer on Joseph Swamp, restoration of vegetation on a fish pond and outflow stream and conversion of twenty-five (25) acres of pasture to longleaf pine seed orchard forest. An education and biodiversity center will also be established in an existing 4,300 square foot house located on the property. The education and biodiversity center will support the conservation, protection and restoration of the endangered longleaf pine/pitcher plant ecosystem in Virginia at the 232 acre Joseph Pines Preserve which adjoins the subject property.

The Planning Commission at their October 7, 2013 meeting voted 10 to 2 to approve Comprehensive Plan Amendment #2013-01 to change the Future Land Use Map designation for Tax Parcel 12-(2)-3A from Residential to Agricultural/Forested/Open Space.
