### Item 3e. Furlough Day for Constitutional Officers and Employees

Mr. Morrison: "At the Finance Committee meeting, it was brought to their attention that the state has mandated a furlough day that will include all Constitutional Officers and their employees and must be used between May 28 and June 30, 2010. I will let the Chairman of the Finance Committee provide additional information and make the recommendation to the Board."

Supervisor Fly: "The Finance Committee looked at this and basically, we have taken a position that we will not fulfill or cover any more state cuts that are being made. The County has covered all state cuts up until this point and we are trying to balance the 2010 budget. It is the opinion of the Finance Committee that we just let this one go by and not absorb the costs. The impact will be: Treasurer's Office \$379.00; Commissioner of the Revenue, \$328.00; Commonwealth's Attorney's Office, \$829.00; Sheriff's Department, \$5,205.00 and Circuit Court Clerk's Office, \$713.00 for a total of \$7,516.00, we are recommending that this not be made up by the County. And that's my recommendation to the Board."

The Board held a brief discussion on this issue.

# Item 5. Action on Secondary System Six Year Road Plan

WHEREAS, this Board had previously agreed to assist in the preparation of this Plan, in accordance with the Virginia Department of Transportation policies and procedures, and participated in a public hearing on the proposed Plan (2010/11 through 2015/16) as well as the Construction Priority List (2010/11) on May 13, 2010 after duly advertised so that all citizens of the County had the opportunity to participate in said hearing and to make comments and recommendations concerning the proposed Plan and Priority List, and

**WHEREAS**, Jerry W. Kee, Assistant Residency Administrator, Virginia Department of Transportation, appeared before the Board and recommended approval of the Six-Year Plan for Secondary Roads (2010/11 through 2015/16) and the Construction Priority List (2010/11) for Sussex County; and

**NOW, THEREFORE, BE IT RESOLVED** that since said Plan appears to be in the best interests of the Secondary Road System in Sussex County and of the citizens residing on the Secondary System, said Secondary Six-Year Plan (2010/11 through 2015/16) and Construction Priority List (2010/11) are hereby approved as presented at the public hearing.
