T. Robertson Blount, Director of Finance, gave an update on the Sussex County School Board FY16 Budget.

Pursuant to Section 15.2-2506 of the Code of Virginia the Sussex County Board of Supervisors Public Hearing is receive citizen comments on the FY16 Sussex County School Board Budget in the amount of \$17,920,480.00. The Local Contribution is \$7,959,170.00, a decline of \$88,000.00 below the current years funding. There is also \$35,000.00 included in the County's budget for shared technology services with the School Board. The projected school enrollment for FY16 is 1,053 students. The per-pupil cost is \$17,018.50.
