## <u>Item 6. Overview of the Proposed Fiscal Year 2015 Budget</u> 7:18:54 PM

County Administrator Harris provided an overview of the proposed Fiscal Year 2015 budget. He shared a Power Point Presentation of the proposed budget. He recommended that the Board invest \$88,000.00 to the Sussex County Public School System to set up a 4 year old program.

Supervisor Hamlin recommended that the Improvement Association be funded in the amount of \$64,000.00 as requested and that the balance be taken from the Contingency Fund.

ON MOTION OF SUPERVISOR HAMLIN, seconded by SUPERVISOR STRINGFIELD that the Board of Supervisors hereby approves funding for the Improvement Association in the amount of \$64,000.00 and approve funding for the School System an additional \$88,000.00 to begin a 4 year old program.

After some discussion, Chairman Fly asked Supervisor Hamlin to restate his motion.

ON MOTION OF SUPERVISOR HAMLIN, seconded by SUPERVISOR STRINGFIELD that the Board of Supervisors hereby approves funding for the Improvement Association in the amount of \$64,000.00 and approve funding for the School System an additional \$88,000.00 to begin a 4 year old program.

Chairman Fly offered a substitute motion to approve the \$7,500.00 for the Improvement Association; seconded by Supervisor Futrell, to be moved from the Contingency Line Item to the Outside Agency Line Item for the Improvement Association.

Motion fails due to a tie vote.

County Attorney Packer stated that this is a little complicated because the motion would have amended the proposed budget by \$7,500.00 and advised that he would have to do research to determine whether or not the tie breaker has the ability to break that type of tie. He suggested that the Board consider passing the budget without making the change as presented in the stated motion, since the money is still in the budget in the contingency fund and the Board has the ability to move that at a subsequent time.

Chairman Fly called for the vote on the primary motion to fund the Improvement Association in the amount of \$64,000.00 and fund an additional \$88,000.00 to the School System to begin a 4 year old program.

## Item 8. Adoption of Fiscal Year 2015 Budget (9:02 pm)

ON MOTION OF SUPERVISOR CAPLE, seconded by SUPERVISOR HAMLIN and carried: RESOLVED that the Sussex County Board of Supervisors hereby affirms that the Fiscal Year 2015 Budget was properly advertised for public hearing; and

FURTHER RESOLVED that the Sussex County Board of Supervisors hereby approves the Fiscal Year 2015 budget in the amount thirty-eight million, four hundred, sixtynine, thousand, three hundred, twenty-six dollars (\$38,469,326.00); and

FURTHER RESOLVED that the Fiscal Year 2015 budget: does not include the extra \$500,000.00 contingency; does include an additional \$88,000.00 from fund balance to be part of the lump sum appropriation to the School Board to be used for a four year old program; and does include the transfer from a line item, \$7,500.00 contingency to the Improvement Association's allocation.

## <u>Item 9. Appropriation of Fiscal Year 2015 Budget</u>

ON MOTION OF SUPERVISOR STRINGFIELD seconded by SUPERVISOR HAMLIN and carried: RESOLVED that the Sussex County Board of Supervisors hereby appropriates the Fiscal Year 2015 budget in the amount of thirty-eight million, four hundred, sixty-nine thousand, three hundred, twenty-six dollars (\$38,469,326.00).

County Attorney Packer stated that since the Board has now resolved the tie vote that occurred earlier in the meeting, by adopting the original motion, it is no longer necessary for him to do the research to determine if the tie breaker is needed in that particular situation. But he will become more knowledgeable about that issue in general, so it similar situation arises, he will be able to advise the Board without having to do additional research.

## <u>Item 10. Approval of Fiscal Year 2015 Intergovernmental Transfers</u>

ON MOTION OF SUPERVISOR FUTRELL, seconded by SUPERVISOR STRINGFIELD and carried: RESOLVED that the Sussex County Board of Supervisors hereby approves the Intergovernmental Transfers for Fiscal Year 2015 in the amount of fourteen million, one hundred nineteen thousand, six hundred eighty-eight dollars (\$14,119,688.00).

County Attorney Packer stated that there are specific numbers for the budget and the appropriations starting July 1<sup>st</sup>. He recommended that all appropriations coming to the Board on and after July 1<sup>st</sup> will show the total dollar amount presently appropriated in that particular fund, the amount of increase or decrease that is being recommended and then the new total, as it relates to that expenditure. On the same proposed resolution, will be the amount of money that has been projected from the revenue source being used to fulfill that appropriation, the total number, the amount of increase or decrease that will come from that general fund number and then the new number that will then be, if the Board approves that resolution, the total amount of that revenue source. And then the next time that it's done, we will have the new numbers. That will help the Board to know where it is as it relates to its budget and appropriations and also cause the Board to know whether or not

what the Board is anticipating to appropriate exceeds one percent of the total budget. Under state law, when you appropriate during the fiscal year, an amount of money that exceeds one percent of the previously adopted budget, you must advertise and hold a public hearing before that change is made.

## Item 13a. Letter by Thomas E. Harris, County Administrator (Resignation)

"It is with the utmost respect and concern for my staff and the people of Sussex County, along with a very heavy heart, that I stand before you this evening to tender my resignation as County Administrator; effective October 1, 2014. In so doing I

want each of you to know that serving as Sussex County Administrator has been a position that I have loved, in a community that I love and without a doubt I consider it one of the greatest honors and privileges that I have had over my thirty plus years in public service. Consequently it should come as no surprise that this announcement is the end result of days of personal anguish and arrives with many regrets.

I regret that I will not see the growth and prosperity of the County that I have dedicated myself to for the past three years, I regret that I will no longer be able to work with the many fine employees and elected officials of the County, I regret that I will not have the honor of announcing those businesses and the corresponding jobs that I have worked so hard to recruit over the past several months, I regret that I will no longer be able to assist the many residents in need in the County, I regret that I will not be there as our Tigers successfully compete in the classroom and on the athletic fields, and most importantly I regret that I will no longer be able to help provide stability, focus, vision, collaboration and selfless leadership to a community that is in such desperate need of each.

None-the-less there comes a time in every man's life when he must reflect, evaluate and assess his and his family's future, along with an objective understanding of the real needs of those he most cherishes.

As you know, I am blessed with a beautiful and loving wife, a close family, supportive colleagues and friends and over the past several months, these are the people I have turned to and shared my concerns and desires with; and as a result of the aforementioned protracted struggle, like many before me, Rebecca, Ariel and I have concluded that my need to explore new interests, combined with our love and respect for the Sussex community and our desire to build for our future requires that I now step aside and move on to more beneficial and perhaps less stressful opportunities in a timely and professional manner.

To this end, I must acknowledge that I am proud of my three year tenure in Sussex as part of a thirty plus year public service career in Virginia, one that has allowed me to travel the world, to have two books and multiple articles written about my public administration contributions, to be the first, and perhaps only, local government administrator to ever serve on a United States Delegation to the United Nations, and perchance, more significantly, one of the very few Public Administrators that had citizens voluntarily rally to his defense with time and money so that he could be reinstated to his former position ... and let me say here that each of these life changing events remains a cherished memory of hopefully a life well spent in the public domain.

However as my family continues to grow, I more and more realize the value of being, and a need to be, a more available and supportive husband for Rebecca, a more attentive and active father for Ariel and her siblings, as well as, a more visible and nurturing grandfather to three (and counting) beautiful children.

So in conclusion let me take this opportunity on behalf of Rebecca and myself, to thank those Board members who have been so loyal, along with our staff and our people, for the faith and support placed in me over the years; even as I earnestly pray that a Merciful God will extend to each his blessings and protection.

And finally, may I add that with an unceasing admiration of your constancy and devotion to Sussex, and a grateful remembrance of your kind and generous consideration for myself and my family, I bid each of you an affectionate farewell."
