a. VDOT Proposed Secondary Six Year Plan for Fiscal Year 2015/2016 – 2020/2021 & Secondary System Construction Plan and Budget for Fiscal Year 2015/2016

Mr. Gerald W. Kee, Assistant Residency Administrator, Virginia Department of Transportation, provided an overview relative to the Proposed Secondary Six Year Plan for Fiscal Year 2015/2016 – 2020/2021 & Secondary System Construction Plan and Budget for Fiscal Year 2015/2016. b. Rezoning Application #2015-02, Michael H. Martz, applicant

Staff report for Ordinance Amendment #2015-02, Michael H. Martz, applicant, was provided by Lorenzo Turner, Assistant to the Director of Community Development. Staff report and supporting documents were included in Board packet.

Statement of Request

The applicant, Michael H. Martz, is requesting to rezone approximately 3.11 acres of tax parcel number 147-(A)-27, consisting of a total of 6.19 acres, from A-1, General Agricultural District, to B-2, General Business District, for speculative commercial development. The site in question is located at the northwest intersection of Blue Star Highway (U.S. Route 301) and Mayes Street (Route 1102) in the Henry Election District.

Planning Commission's Recommendation – Approval

The Planning Commission held a public hearing on April 6, 2015 to consider this request and voted unanimously (12 - 0) to send this matter to the Board of Supervisors with recommendation for approval.

Rationale for Approval

A rezoning from A-1, General Agricultural District, to B-2, General Business District, would be consistent with the County's Comprehensive Plan which has the site in question designated for future commercial development.

A portion of the property in question (located within the corporate limits of the Town of Jarratt) is presently zoned for commercial use.

There is an existing retail establishment (Dollar General) which adjoins the affected site.

There has been no opposition to the request.

Item 11a. County Administrator's Report

1. Presentation – The Improvement Association

Ms. Ginger Wrenn, Program Coordinator for the Improvement Association, announced that May is recognized as the National Community Action Month. In honor of the National Community Action Month, Ms. Wrenn provided an overview. "War on Poverty" was declared and Congress adopted the Economic Opportunity Act in 1964 resulting the development of Community Action Agencies. The Improvement Association is Sussex County's first Community Action Agency.

The Improvement Association started out with three (3) employees and now has over 75 employees providing services in six (6) different localities. The Improvement Association service areas include Dinwiddie, Emporia, Greensville and Sussex.

Ms. Wrenn discussed two (2) of their programs: In-School Youth and Out-of-School Youth. Ms. Wren gave brief overviews on enrollment, return investment and outcomes of the POWER Program. Handouts were provided with further details.

Mr. William Ricks, Program Coordinator of Project Discovery for the Improvement Association, provided information on the operation Project Discovery. Project Discovery is a community based, non-profit program throughout the Commonwealth of Virginia. It assists potential first generation college attendees in overcoming the educational, financial and cultural barriers. Project Discovery serves over 67 students in Sussex County in grades 6 -12. Project provides visits to various college campuses for student. The Project Discovery also offer waivers for low income student for SAT, ACT and college application fees for those students pursing college degrees. Handout were provided with details of services and programs offered through Project Discovery.

Ms. Erica Singleton, Housing Coordinator for the Improvement Association, provided an overview of Housing/Prevention Program assisting the community with housing issues and homelessness. Reports were given as to the number of people in community assisted. Ms. Singleton gave an overview on homelessness prevention, Improvement Association goals, outcomes for FY14 and return investment. Handouts were provided as well.

Ms. Faye Perkins, Human Resource Payroll Officer for the Improvement Association, gave a brief "Outcome Overview" of Headstart Program. Currently there are sixty-six (66) children (3 – 4 year olds) receiving comprehensive services to enhance their social, intellectual and emotional growth. The Improvement Association has four (4) classrooms in Sussex County. Staff is working with families to get GEDs and become gainfully employed. Handouts were provided with further details.

The Improvement Association will be hosting a Community Action Day to be held at the Stony Creek Park Saturday, May 30, 2015 from 11:00 am to 2:00 pm.

Mr. T. 1. Gin Hill Property Acquisition

County Attorney Mike Kaestner provided a background report of EEE Consulting, Inc., an environmental contractor, monitoring and compliance responsibilities with respect to the two closed landfills—Gin Hill and Robinson Road. (Background information provided in the Board packet.)

EEE Consulting, Inc. recommended that the County acquire ownership of this property, stating that:

the additional property is necessary to demonstrate to the Virginia Department of Environmental Quality that all landfill gas and landfill related groundwater contamination is confined/limited to County-owned property. If there is a potential for off-site migration, DEQ will prolong and possibly expand groundwater monitoring requirements."

- 2. To authorize the County Administrator to execute the purchase and sale agreement to acquire the property adjacent to the Gin Hill Landfill as described by the County Attorney at the Board of Supervisors' May 21, 2015 meeting.
