Item 13. Report from Departments/Staff/Commissions (reports included in Board packet)

Eddie T. Vick, Public Safety Coordinator, provided a brief monthly report on Animal Control Services to the Board. Mr. Vick reported on building maintenance to the animal shelter, landscaping, and updating Animal Control Services and working on Animal Control Services policy to be implemented on October 1, 2015. He also reported on the rescue and adoption of animals for the month.

Mr. Vick advised of the hiring of new part-time employee, Kristie Massey, and discussed projects Ms. Massey was handling.

Vandy V. Jones, III, Deputy County Administrator, provided a brief report on some of the projects of the staff.

Mr. Jones reported on the replacement of road signs. Mr. Gilliam, Building and Grounds supervisor, and staff have replaced ten (10) road signs thus far. Those road signs that have been replaced were listed in the Board packet. The Building & Grounds staff plan to devote time each week for the replacement of road signs.

Mr. Jones also provided an update of the Courthouse Roof repair. He advised the Board that work had resumed. The Cupula was to be completed Friday, September 18, 2015. The remaining roof work was expected to be completed by the end of the following week. The contractor completing the roof repair was asked to evaluate the windows in the County office building where the Treasurer and the Commissioner of the Revenue are housed. The report of the evaluation is expected to be completed by the end of the following week (September 25th).

Mr. Jones gave a brief report of Industrial Development Authority (IDA) Board of Directors meeting held September 14, 2015. He advised that Mr. Eugene Brittle was elected Chairman. Mr. Bruce Spencer was elected Vice Chairman. County Administrator Davis was elected Secretary/Treasurer. Mr. Jones also advised that Rene Chapline, President and CEO of Virginia Gateway Region, was present at the IDA meeting. Ms. Chapline provided information regarding assets of the region, data bases available and prospect development. He advised that Mary Rae Carter, Special Advisor of Rural Development, Office of the Secretary of Commerce and Trade was present at the IDA meeting. Ms. Carter provided information of partners available at State level and workforce development.

Mr. Jones advised that staff met with the website designer and discussed ways to make site more user friendly—fewer clicks to find information—and keeping site updated. Staff will have continued discussions with web designer as staff continues to work to upgrade the County website.
